






L.E.K. Consulting and Guidepoint conducted a survey of 50 hospital executives across public and private hospitals in the United Arab Emirates and the Kingdom of Saudi Arabia

We explore three key areas from the GCC Hospital Priorities 2022 survey: financial outlook, strategic priorities and digitalization/innovation



Financial outlook

Providers seem to be in better financial position than they were during the pandemic and there is increasing optimism for better financial performance across private and public providers over the short-to-medium term



Strategic priorities

Providers are focused on improving clinical outcomes/patient care as well as operational efficiency through cost reductions and standardization of clinical protocols underpinned by investments in new digital capabilities



Digitalization and innovation

Most hospitals are indicating a strong focus on digitalization and innovation, focusing on solutions that improve clinical outcomes, operational efficiency and patient satisfaction



Private hospitals have recovered quicker than public hospitals from the impacts of COVID-19; general economic growth and cost reductions are expected to underpin future profitability







Financial outlook


- Private hospitals have recovered better than public hospitals from the impact of COVID-19, and there is increased
 optimism for higher profitability over the short-to-medium term
- Private hospitals have a positive profitability outlook, with large providers having been less severely impacted by the pandemic; 100% of large private hospitals expect future positive EBITDA margins
- A reliance on general economic growth, return of patient confidence in accessing providers, and cost reduction to improve business sustainability is driving private hospital optimism; 62% plan on investing in solutions that track cost at a more granular level





Private hospitals have recovered better than public hospitals from COVID-19 impact and have a positive outlook on profitability over the short-to-medium term






Private hospitals — profitability/EBITDA margin outlook Medium-size private hospitals (≤500 beds) in GCC*










Private providers mention general economic growth, patient confidence, and costs reduction plans, enabled by investments in cost tracking solutions, as the key drivers underpinning business sustainability

Provider strategic priorities include both operational efficiency and care outcome improvements, with an increasing emphasis on standardization of clinical protocols







Strategic priorities

- Providers are focused on improving clinical outcomes, enhancing patient experience and improving operational efficiency through cost reductions and clinical protocol standardization, underpinned by investments in new digital capabilities and expanding/developing clinical staff including their pool of physicians
- These translate to building digital infrastructure and providing clinicians access to new medical technology





Strategic priorities are focused on workflow optimization, reducing the cost of medical supplies and improving digital capabilities to improve clinical outcomes and operational efficiency




Over 55% of surveyed hospitals plan to increase spending on infrastructure, prioritizing digital and nearly 60% on expanding/developing clinical staff including their pool of physicians

Patient engagement solutions across registration, booking, payor coverage and tools to support remote consultations are the top digital solutions already adopted




Digitalization and innovation

- Hospitals are noting that the value of digital health goes beyond increasing revenue streams to improving operational efficiencies and increasing patient satisfaction
- There is broad adoption of online patient registration and appointment booking solutions across the UAE and KSA with over 80% of hospitals having adopted or are trialling the solution
- Remote consultation adoption is advanced in the UAE with over 80% adoption in hospitals; Saudi Arabi has indicated interest in closing the gap
- Adoption of post-discharge monitoring solutions is low at less than 20% across the GCC; there is a willingness to explore potential options
- However, there are concerns around patient privacy, staff readiness to adopt digital solutions in addition to required implementation budgets are some of the main concerns




There is broad adoption of online patient registration and appointment booking solutions across the UAE and KSA with over 80% of hospitals having adopted or are trialling the solution




Remote consultation adoption is advanced in the UAE with over 80% adoption in hospitals; Saudi hospitals have indicated an interest in closing the gap


Adoption of initial consultation / diagnosis solutions*



Over 60% of surveyed hospitals have adopted or are trailing personalized information pushed to patients; HIE solutions are less adopted but there is significant interest






